This is for the information of all concerned that few seats remain vacant in TDC First Semester Arts (B.A). Interested candidates can apply for admission in TDC 1st semester Arts by visiting the Online Admission Portal of the College. Admission will be on the basis of merit.

Again, few applicants who applied for admission in TDC 1st Semester Arts but could not complete the process of total submission in the online Admission Portal earlier can now complete the process of Final submission by modifying their application visiting student login section.

Online Admission Portal will remain open to enable the candidate to apply for admission in TDC 1st Semester Arts on and from 5th to 6th October, 2021.

Further, the students seeking admission in TDC 1st Semester Arts (CBCS) that in continuation of Higher Education Department OM issued vide No. AHE.354/2021/8 dated 06-09-2021 and No. AHE.354/2021/9 dated 10-09-2021, the Governor is pleased to notify that –

1. As an alternative to the **Income Certificate issued by the Circle Officer** as stated in the OM, the Head of the Institution from where the student has passed out may also issue an Income Certificate for the purpose of the **Fee Waiver Scheme** and the same shall be accepted by the institution admitting the student.

OR

2. The Head of an Institution where a student is seeking admission may admit a student under **Fee Waiver Scheme** if he / she is satisfied that the annual income of the parents of the student is below Rs 2.00 Lakh per annum, by recording their satisfaction and issuing an Income Certificate in favour of the student for the purpose.

OR

3. The student or his / her parents may submit a **Notary Affidavit** in respect of his / her Annual Income for availing the **Fee Waiver Scheme** which shall be accepted by the Institution.


4. The Income Certificate so submitted by the candidate will have to be verified by Competent Authority within one year and action as per law will be taken against anyone where submission of false certificate is established.

5. The College Authority may give admission to the students without examining the original mark sheet. However, the admitted students must produce original mark sheet **on or before 15th October, 2021**, otherwise the admission will stand cancelled.

*****Note – For availing Fee Waiver Scheme, a student must submit an undertaking (link for downloading the undertaking form is available in the College website) along with the Income certificate failing which a candidate cannot avail the Fee Waiver Scheme. The Student must mention his / her application number on the upper left corner of the undertaking form.**

All documents (such as Income certificate issued by the Circle Officer / Income certificate from the Head of the Institution / Notary Affidavit & Undertaking) relating to Fee Waiver Scheme must be submitted to the following mail ID at the time of applying / modification of online application form.
