ADMISSION NOTICE

Students of TDC (CBCS) 2nd and 4th Semester (**Arts, Commerce & Science stream**) for the session 2022-23 who have enrolled / filled up TDC Even (2nd and 4th) Semester Examination, 2022 form are asked to fill up application for admission in 3rd and 5th Semester classes for the session 2023-24 through **online mode on or before 23rd July, 2023.**

Before filling up the admission form for 3rd and 5th Semester classes for the session 2022-23, students are asked to go through the following guidelines-

1. Go to the College admission portal <https://krmcoladm.in>.
 2. Click the respective course link.
 3. Students will have to update their Unique ID they have created at the time of admission into HS 1st year / TDC 1st Semester. This is compulsory for online admission. For updating their Unique ID, students will have to visit DHE- ONLINE REGISTRATION PORTAL which is <https://dheonlineadmission.amtron.in/sp/index>. The link is also available in the admission portal of Karimganj College.
 4. Students who have not yet created **ABC ID** will have to create ABC ID from the link available in the admission portal of Karimganj College. Students who have already created ABC ID will have to upload the ABC ID number.
 5. Before filling up the form please ensure that you have the following documents ready:
 - i. Photograph and signature should be in JPG / JPEG format (Max 100 KB).
 - ii. Signature and photograph of candidate.
 - iii. Signature of parent / guardian.
 - iv. Admit card of last semester examination, 2023.
 - v. Scanned copies of all Degree mark sheet.
 - vi. Scanned copy of caste certificate if any (Max size 200 KB).
 - vii. Personal Email ID and mobile number (mandatory). Mobile number mentioned by the students in the application form for admission and mobile number mentioned in his / her savings bank account should be the same.
 - viii. Personal bank account details i.e. savings bank account number, bank name, branch name and IFSC code are mandatory. **Once the data is submitted, the same cannot be changed during the tenure of study in the College, otherwise the said student will be deprived of the Govt. beneficiary scheme, if any.**
 - ix. Scanned copy of domicile certificate by the Govt. of Assam, viz. PRC / Voter ID card of self or parents / NRC of self or parent / AADHAR card of self or parent / BPL card of family / Birth Certificate issued by the Register of Birth and Death / Passport of self or parent.
 - x. Admission payment receipt of 1st Semester for admission in 3rd Semester and admission payment receipt of 3rd Semester for admission in 5th Semester.
 6. **Asterisk field are mandatory.**
 7. After filling up the form, students should click on "**Review Form**" button to review the form and make necessary correction if required.
 8. After successful review click on "**Submit**" and follow the admission.
 9. Students will have to pay admission fees as per following rates by **Net Banking / Mobile Banking / Debit Card / Credit Card** etc.
 - a. As per the letter issued by the Director of Higher Education, Assam for continuation of **Fee Waiver Scheme** vide letter No. **PC/HE/Misc/42/2020/235 dated 29-06-2022**, the Fee Waiver Scheme will be continued for the academic session **2023-24** for admission in TDC classes. For availing the scheme, applicants must go through the following points. **This Scheme is only for regular students having 75% class attendance with no Back / Arrear paper(s) in 1st Semester examination for students seeking admission in 3rd Semester and in 1st, 2nd & 3rd Semester examination for students seeking admission in 5th Semester.**
 - b. As an alternative to the **Income Certificate issued by the Circle Officer** as stated in the OM, the Head of the Institution from where the student has passed out may also issue an Income Certificate for the purpose of the **Fee Waiver Scheme** and the same shall be accepted by the institution admitting the student.
- OR**
- c. The Head of an Institution where a student is seeking admission may admit a student under **Fee Waiver Scheme** if he / she is satisfied that the annual income of the parents of the student is below Rs 2.00 Lakh per annum, by recording their satisfaction and issuing an Income Certificate in favour of the student for the purpose.

OR

- d. The student or his / her parents may submit a **Notary Affidavit** in respect of his / her Annual Income for availing the **Fee Waiver Scheme** which shall be accepted by the Institution.
- e. The Income Certificate so submitted by the candidate will have to be verified by Competent Authority within one year and action as per law will be taken against anyone where submission of false certificate is established.
- f. The College Authority may give admission to the applicants without examining the original mark sheet, but the admitted applicants will have to produce original mark sheet when they are asked for.

****Note- For availing Fee Waiver Scheme, a student must submit an undertaking along with the Income certificate failing which a candidate cannot avail the Fee Waiver Scheme. The Student must mention his / her application number on the upper left corner of the undertaking form.**

- g. For availing benefits of Fee Waiver Scheme, applicants must upload the certificate relating to Domicile of Assam as per the list of Govt. of Assam already uploaded in the admission portal of Karimganj College.
- h. Applicants availing Fee Waiver Scheme will have to pay ₹ 450.00 as admission fee.
- i. Income Certificate and undertaking form can be downloaded from the College website.


