

No. ECF.511514/177.- In exercise of powers conferred under Sub- Section (1) of section 12 of the Assam College Employees (Provincialisation) Act., 2005 (Assam Act No. XI.VI of 2005), the Governor of Assam is hereby pleased to make the following rules further to amend the Assam College Employees (Provincialisation) Rules, 2010, hereinafter referred to as the Principal Rules in the manner hereinafter appearing, namely:-

- Short title and 1. commencement
- (1) The rules may be called the Assam College Employees (Provincialisation) (Amendment) Rules, 2024.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- Amendment of rule 5
- In the Principal Rules, in rule 5, in sub-rule (1), for clause (iii), the following shall be substituted, namely:-
 - "(iii) (a) The term of appointment of Principal of a College shall be for a period of five years,
 - (b) after completion of the term of five years, the said Principal shall be eligible for applying for one or more term of five year in any college, if his age permits, and has a satisfactory performance report from the Government,
 - (c) after completion of the term of five years, the Principals, who does not have sufficient period of service left for applying for another term of five years, such principals shall be eligible for applying for selection in the same college he has been serving, not otherwise and has a satisfactory performance report from the Government. Any such extended term shall be valid only for the remaining period of service until superannuation."

OFFICE MEMORANDUM

Guidelines for Selection of Principals in Provincialised Colleges of Assam. Subject:

In cancellation of all previous Govt. OMs, the Government of Assam in Higher Education Department is pleased to notify the following guidelines for selection of Principals in Provincialised Colleges of Assam.

A Master's Degree with at least 55% marks (or an equivalent grade in a point scale whenever grading system is followed) by a recognised University.

A Ph.D Degree in concerned/allied/relevant discipline(s) in the institutions concerned with (11)

evidence of published work.

Associate Professor/Professor with a total experience of fifteen years of teaching/research/Administration in University/Colleges and other institutions of Higher (111)

A minimum score as stipulated in the Academic Performance Indicator (API) based on Performance Based Appraisal in Appendix III for direct recruitment of Professors in Colleges.

A relaxation of 5% may be provided at the graduate and master's level for the Scheduled Caste/Schedule Tribe/Differently abled (Physically and visually differently abled) categories for (v) the purpose of eligibility and for assessing good academic record during direct recruitment to teaching positions. The eligibility marks of 55% marks or an equivalent grade in a point scale wherever grading system is followed) and the relaxation of 5% to the categories mentioned above are permissible based on only the qualifying marks without including any grace mark

A relaxation of 5% may be provided from 55% to 50% of the marks to the Ph.D Degree holders. who have obtained their Master's Degrees prior to 19th September, 1991. (vi)

Upper age limit of 55 years as per prescribed Rules. (vii)

Now the UGC vide regulation dated 18-07-2018 has modified the eligibility criteria for the post of Principals of Provincialised Colleges as shown below:

Ph.D Degree. (i)

Professor/Associate Professor with a total service/experience of at least fifteen years of (ii) teaching/research in Universities, Colleges and other institutions of Higher Education.

A minimum of 10 research publications in peer reviewed or UGC listed journals.

A minimum of 110 Research Score as per Appendix II at Table-2.
